## Narrative

On June 16, 2021 at 17:07 hours, an agency assist occurred at the 1000th block of N. Bankerd Avenue in Nogales, Arizona Santa Cruz County.

#### Supplement Officer: G Batriz

While working Operation Stonegarden and assigned to the W. International St area, Officer D. Lopez #251 advised via radio that United States Border Patrol Agents were involved in a shooting incident. At the same time two Border Patrol units were exiting the W. International St area code 3. I followed code and arrived at the scene, which was the 1000th block of N. Bankerd Avenue. Once on scene, I saw several United States Border Patrol Agents providing medical care to a rear passenger inside of a white SUV. The White SUV was a 2004 Kia bearing Arizona license plate of

I asked Border Patrol Supervisor T. Serrano #N55 if any agents were hurt and he said, "no". I advised Agent Serrano that Police Stone garden units were going to assist with traffic control and securing a perimeter. I also asked him if he needed anything else and he said, "no". I asked Agent Serrano if he could provide me with information and he told me hat all he could say was that they had a fail to yield with the Kia, and one shot was fired. Agent Serrano did not provide me with further information. Stone garden units stayed on scene until arrival of the Border Patrol CIT team and Federal Bureau of Investigations.

This concludes my involvement in this matter.

### Supplement Officer: F Serrano

On June 16, 2021 at approximately 17:07 hours, I responded to a agency assist to United States Border Patrol. Dispatch advised shots fired at the area of Bankerd Avenue and Doe street.

I responded in my unmarked patrol vehicle with lights and sirens (code 3).

Upon arrival, I placed barrier tape at the north side of the scene. I then assisted units with traffic control until I was relieved by Corporal S. Bunting #237.

No further involvement in this incident.

#### Supplement Officer: M Quezada

On June 16, 2021, at approximately 17:07 hours, Officer D. Lopez #251 advised via police radio that he was waved down by a United States Border Patrol agent, who informed him of a shooting involving a Border Patrol agent, in the area of North Bankerd Avenue, in Nogales, Arizona.

Once I heard Officer Lopez's radio transmission, I proceeded to respond to the area of North Bankerd Avenue, activating my sirens and my red and blue emergency lights.

As I was approaching the area, I observed several other Border Patrol marked vehicles, heading the same way. As I was arriving at North Bankerd Avenue, approaching East Doe Street, I saw that North Bankerd Avenue was shut down, being blocked by several unmarked vehicles. I looked south of East Dor Street on North Bankerd Avenue, where I observed a white SUV with its door wide open, facing north, stationary on the southbound lanes. As I was running towards the white SUV, I heard an agent yelling if anyone had a first aid kit. I yelled back that I had one and ran back towards my fully marked patrol vehicle, where I grabbed my department issued first aid kit.

Once I had the first aid kit, I ran back to the white SUV and observed two male subjects handcuffed on the sidewalk, two female subjects wearing camouflage clothing sitting on the sidewalk and a third female subject also wearing camouflage clothing, sitting on the back seat of the white SUV, who had an injury to her left eye area. I began to open my first aid kit as I was asked by an undercover female agent if I could assist them. I handed my first aid kit to the agents surrounding the vehicle as I stepped back and let them handle the situation. Moments later, the Nogales Fire Department arrived on scene and they began to medically treat the female subject injured.

I then met with Corporal A. Vasquez #231 who informed me that the Nogales Police Department working the stone garden operation, would be assisting Border Patrol agents with this incident. I walked back to the scene and grabbed my first aid kit, which was no longer needed.

Before I cleared from the scene, Officer F. Serrano #219 who was working the stone garden operation and was already on scene, asked me for spare yellow crime scene tape, which I provided to him.

This concluded my involvement in this matter, nothing further to report.
